DIRECTIONS

Always test carpet and delicate fabrics in an inconspicuous area. Read and follow directions for best results.

Organic & Protein (Urine, Food, Beverages):

1. Remove as much of the staining matter as possible. Soak the stain with **Encapsulating Spotter™** and tamp with spotting brush.
2. Allow a few minutes dwell time.
3. Blot excess with a clean, absorbent cloth.
4. Repeat procedures if stain persists.
5. Vacuum the area after it has dried.

Re-appearing Stains:

1. Re-soak spot, agitate and allow 10 minutes dwell time.
2. Extract thoroughly with clean water.
3. Vacuum the area after it has dried.

Oil-based stains (Cosmetics, Inks, Grease):

1. Soak the stain with Encapsulating Spotter™ and agitate with spotting brush.
2. Allow a few minutes dwell time.
3. Blot excess with a clean, absorbent cloth.
4. Repeat procedures if stain persists.
5. Vacuum the area after it has dried.
