Directions

Before Cleaning:

Test on surface before using. Apply a small amount of product to an inconspicuous area. If surface mars, dulls, discolors, fades or fiber color transfers to a white cloth, do not use.

Do not use silk, satin, velvet, leather, suede, latex, painted or varnished wood surfaces. May dull some plastics.

Carpet & Upholstery:

1. Apply **Unbelievable® Citrus Gel™** directly to stained area.
2. Use Core's **T-Bone™**, the 3-in-1 spotting tool or brush to work into stained area.
3. Blot with an absorbent, clean, white, towel.
4. Repeat until stain is removed.

Do Not Mix with Bleach or use in conjunction with any household products. HARMFUL IF SWALLOWED.

Use in well ventilated area. Eye contact or prolonged skin contact may be irritating. Wear protective eye gear and chemical resistant gloves for prolonged use.
