DIRECTIONS

Before Cleaning:

Test on surface before using. Apply a small amount of product to an inconspicuous area. If surface mars, dulls, discolors, fades or fiber color transfers to a white cloth, do not use.

NOTE: A proper procedure to successfully test for colorfastness is to apply solution to a clean, white absorbent cloth. Be sure to blot all colors and check for dye transfer. Dry each blotted area using a hair dryer, checking for color change and/or 'bleed.'"

Do not use silk, satin, velvet, leather, suede, latex, painted or varnished wood surfaces. May dull some plastics.

Carpet & Upholstery (Tannin & Browning)

1. Apply **Unbelievable!® TANN-X™** directly to stained area. Do Not Dilute!
2. Blot with an absorbent, clean, white, towel or sponge.
3. Extract as normal while applying a light spray of neutral detergent. If necessary, repeat procedures after carpet or upholstery has thoroughly dried.

Large Carpet Stained Areas (Tannin & Browning)

1. Apply **TANN-X™** to stained area using a utility pump sprayer (course nozzle—DO NOT MIST).
2. Rake area with carpet comb in two directions and allow dwell time until tannin or browning is reduced or disappears.
3. Repeat Step 3 (Extract as normal).

Do Not Mix with Bleach or use in conjunction with any household products.

HARMFUL IF SWALLOWED.

Ingredients: Water (CAS#7732-18-5), Sodium Metabisulfite (CAS# 7681-57-4).

PROTECT FROM FREEZING.
