DIRECTIONS

Before Cleaning:

Test on surface before using. Apply a small amount of product to an inconspicuous area. If surface mars, dulls, discolors, fades or fiber color transfers to a white cloth, do not use. Do not use on styrene plastics. Test all plastics before using. For upholstery, always test on bottom or back first.

For Brick, Concrete & Stucco:

1. Apply to problem area, wait 3-5 minutes.
2. Use brush to loosen dried paint. Use hose to rinse off and wipe clean with a towel.
3. For best results on a porous problem, use high pressure spray washer after Step 1.

For Hard & Soft Surfaces (Street Signs, Tile, Etc.):

1. Spray stain thoroughly, wait 60 seconds.
2. Wipe with clean disposable towel or cloth.
3. Repeat if necessary.

Do Not Mix with Bleach or use in conjunction with any household products.

Contains:

Water CAS# 7732-18-5; Ethylene Glycol Monobutyl Ether CAS# 111-76-2; Acetone CAS# 67-64-1; Fragrance.

In Case of Spill:

- Wear suitable protective equipment. Eliminate ignition sources.
